1. Promoter

2. Eligibility

2.1 Entry is open only to natural persons who are residents of Melbourne, Australia, aged 4 to 13 years ("Eligible Entrants"), as submitted by their parent/guardian.

2.2 Only one (1) entry per child will be accepted.

2.3 Employees, directors, contractors, and immediate family members of the Promoter and its related entities are ineligible to enter.

3. Promotion Period
